Privacy Policy for Al Hacks & Stacks Google Workspace Add-ons

Effective Date: April 9, 2025

This Privacy Policy describes how AI Hacks & Stacks ("we," "us," or "our", "aihas") handles information in connection with your use of the our Google Workspace Add-on (the "Add-on").

1. Information We Collect and Process

The Add-on is designed to operate directly within your Google Workspace environment. We prioritize your privacy and minimize data collection.

- Google Account Information: To use the Add-on, you must grant authorization via Google's standard OAuth consent screen. This process is handled by Google, and the Add-on only receives the necessary permissions (scopes) to function, such as accessing the current spreadsheet you are actively using (spreadsheets.currentonly) and creating user interface elements (script.container.ui). We do not receive or store your Google account password or profile information directly.
- **Spreadsheet Data:** The core function of the Add-on involves processing data directly from the cells you select within your active Google Sheet. The Add-on reads the content of the selected cells, combines this content, writes the combined result back into the top cell of your selection, and deletes the rows below the top cell *only* upon your explicit confirmation via a dialog box. This processing happens ephemerally during the execution of the Add-on's function.
- Data Storage: We do not store your spreadsheet data on any servers owned or controlled by us. All processing occurs within Google's infrastructure as part of the Apps Script execution, and the final result is saved directly back into your Google Sheet.
- **Usage Data/Analytics:** We do **not** collect any personal information or usage analytics about how you use the Add-on (e.g., frequency of use, errors encountered).

2. How We Use Your Information

The information processed by the Add-on (specifically, the data from your selected cells) is used solely for the purpose of providing the Add-on's functionality: combining cell content and deleting specified rows within your Google Sheet, as initiated and confirmed by you. We do not use this data for any other purpose, such as advertising or analysis.

3. Data Sharing

We do **not** share any of your spreadsheet data or personal information with any third parties. All processing is contained within the Google Workspace environment under your control and the execution environment provided by Google Apps Script.

4. Data Security

We rely on the robust security measures provided by Google Cloud and Google Workspace infrastructure to protect data during processing. As we do not store your data, the security of your data primarily relies on your own Google account security and Google's platform security.

5. User Rights

Data privacy laws may provide you with rights regarding your personal information. As we do not store your personal data, requests regarding access, correction, or deletion should primarily be directed towards managing your data within your Google Account and Google Sheets. For information on managing your Google Account data, please refer to Google's privacy policy and account settings.

6. Children's Privacy

The Add-on is not intended for use by children under the age of 13 (or the relevant age of digital consent in your jurisdiction). We do not knowingly collect any personal information from children.

7. Changes to This Privacy Policy

We may update this Privacy Policy from time to time. We will notify you of any significant changes by posting the new Privacy Policy, potentially through the Add-on listing or other means. Your continued use of the Add-on after such changes constitutes your acceptance of the new Privacy Policy.
